



# HOW CAN OUR PRC HELP?

## SPONSOR A "BRICK"

---

Inspired by the Book of Nehemiah, we want to see Floridians across the state come together to rebuild a wall of protection around the preborn through a constitutional amendment that recognizes the God-given right to life of the preborn.

Our building bricks are reams of paper on which 500 petitions can be printed. Would your PRC consider sponsoring a "brick" by printing 500 petitions and committing to getting each of these signed by registered Florida voters in your area?

## HELP ENGAGE LOCAL CHURCHES

---

According to a 2022 Gallup Poll,<sup>1</sup> there are over 5 million registered Florida voters that would likely sign our petition without hesitation if they simply knew about it.

That's why we need your help connecting us to like-minded individuals in your area.

Which churches partner with your organization, or attend your annual event? Who do you know that attends or pastors these churches? Ask if they would be willing to assist in our petition gathering efforts to secure ballot placement in 2024 for our proposed amendment to recognize the God-given right to life of the preborn.

## DISTRIBUTE PETITIONS AT UPCOMING EVENTS

Do you have an upcoming volunteer meeting, conference, Walk for Life, or annual banquet?

These are wonderful opportunities to get petitions signed. Consider passing them out, placing them at each table setting, having volunteers collect signatures on clipboards, or designating a table for petition signing.

According to the IRS, activity on ballot measures is considered lobbying - not electioneering. Therefore, churches, PRCs, and other nonprofit charitable organizations can participate in ballot measure activities without fear of compromising their 501(c)(3) status.
